
Joshua solemnly reminded his people, "Ye have not passed this way heretofore." (Joshua 1:5) But at the same time he advised them to keep their eyes

He has a vision of many people coming to know the Lord through this ministry.

Vickie also comes from Rockford and has been a Chrisitan for about four years. Hers is a familiar face at the Cup, since she has been helping in various ways for quite sometime now. She feels it is a great privilege to work for the Lord at the coffee house and believes it is an answer to her prayers to work with young people in Beloit. Vickie spent four months with Teen Challenge in El Paso, Texas and feels she learned alot of lessons while she was there that helped prepare her for this type of ministry. When she was asked how much responsibility whe wanted, her reply was: " More that I can handle because that way the Lord will have to do it and I will have to trust Him more." As for Vickie's goals, she says: "I just want to serve the Lord. I don't have any big plans."

We will be in the background to guide and support Vickie and Dean and we ask you to pray with us for them as they begin their new positions at the Cup. Also, ask God to show you how you might help them. We praise the Lord for their willingness to take the initiative and step out in faith to help the Overflowing Cup realize its potential effectiveness for the Lord. We hope many others will follow their example of true discipleship.

INITIATIVE - now that's an interesting word. Let's kick it around awhile. The dictionary defines its meaning this way: 1. active part in taking the first steps in any undertaking. 2. readiness and ability to be the one to start a course of Hmmmm! Did you ever think about God's initiative? I could never thank Him enough for taking the initiative in loving me when He sent Jesus, thus setting the whole plan of salvation into motion, even before I could love Him. That, my friend, is initiative! How's your initiative lately? Do you have the kind that's willing to make the first move in loving people who don't know about God's initiative or have never experienced His Love? Can you take the initiative and love people even when they don't love you? If you've got that kind of initiative, the coffee house is a good place to put it into practice. If you haven't got any, "ye have not because ye ask not". Which brings us to the need of the hour. . . more qualified counselors to share their faith and be available as good, caring-type listeners - the kind who don't just listen, but offer solutions to problems and can pray for the needs of those troubled and perplexed people trying to handle life without the Lord.

PROCRESS REPORT: We are moving rather slowly and it is sometimes frustrating when we think about how much could be accomplished in all areas of the ministry if we just had more manpower. However, thanks to the faithfulness of a few, the Book Store is almost ready to inhabit. We didn't make it by Christmas as we had hoped, but then we didn't say which Christmas, did we?

We are presently concentrating on the library and hope to have it open soon. We are adding new tapes and books as they become available and know you will appreciate having access to them. We plan to have a room for listening to tapes and could use some cassette recorders for that purpose as well as loaning to shut-ins and those who don't have recorders but would like to take advantage of the good teaching that is available on tapes.

In order to increase the effectiveness of the ministry, we feel that we need to be open more hours and we are constantly reminded of the need to make the sleeping rooms available. We are also increasingly aware that we need to develop our recreational facilities to meet the needs of the Jr. High age group. Meaching them at an earlier age level could keep many young people from heading down the wrong road later on. But, all of these needs are greatly hindered by the manpower shortage and a limited amount of funds.

As a means of increasing our income, Dave has sold a mailing service system to the Overflowing Cup for a \$1.00 (just to make it legal). He developed this system to help us with our mailing and it has proved quite a time-saver for other organizations and churches who use it regularly. We would appreciate an opportunity to help you with your mailing and benefit our ministry at the same time. Remember, all profits go to the coffee house ministry, so give us a call if you could use this service.

By the way, for those of you who may not be aware of it, we are recognized by the Internal Revenue Service as a non-profit corporation with tax-exempt status making all of your contributions tax-deductible.

Before we sign off for this month, we'd like to say a brief word about another member of our organization. He is quite new around the premises, coming to us all the way from Indiana. He came to Beloit to live with a friend but became destitute when he couldn't find a job and homeless when he couldn't pay his rent. So, we took him in and gave him the responsibilities of custodian and night watchman at the Cup. His name is Samuel because, like Samuel in the Bible, he has come to the Lord's House to do the Lord's work. He's also been assigned the position of Public Avenue Mice Chaplain and was last seen counseling our mouse clientele with regard to finding new housing facilities so He wouldn't have to exert himself by chasing them. In case you haven't guessed, Samuel is a cat who is in dire need of of foster home. Isn't it neat that God cares about the little things? I only hope the mice see it that way.

I want to mention one more thing that we definitely feel the Lord leading us to begin and that is a Christian weight-watchers group, Plans are being formulated and we hope to begin meetings sometime in January. IN THE BEGINNING . . . God created Heaven and Earth

He was then faced with a class-action lawsuit for failing to file an environmental impact statement with HEPA (Heavenly Environmental Protection Agency), an angelically staffed agency dedicated to keeping the universe pollution free.

Also the HHUD (Heavenly Housing and Urban Development) required an immediate HHUD filing plus refunding of all monies to any purchasers. God explained that there would be no profit out of solar systems sales and that only one parcel was involved so HHUD and HEPA granted permission for God to proceed.

God was granted a temporary permit for the heavenly portion of the project, but He was issued a cease and desist order on the earthly part, pending further investigation by HEPA.

This was not considered adequate reasoning and He would be required to substantiate this further!
